

SUBORDINATION AGREEMENT

STATE OF ALABAMA
COUNTY OF SHELBY

This Subordination Agreement, made and entered into this the 25th day of MARCH, 19 92, by and between SOUTHTRUST BANK OF ALABAMA, NATIONAL ASSOCIATION, P.O. BOX 2554, BIRMINGHAM, ALABAMA, as Party of the First Part, and SOUTHTRUST MORTGAGE CORPORATION, as Party of the Second Part.

W I T N E S S E T H

THAT, WHEREAS, CECIL F. GREENE AND NANCY S. GREENE has/have an outstanding lien in favor of SOUTHTRUST BANK OF ALABAMA, NATIONAL ASSOCIATION, dated SEPTEMBER 14, 1988 and recorded in the Probate Office of SHELBY County, Alabama, in BOOK 207, PAGE 158 on certain real estate described therein to secure an indebtedness of \$ 81,600.00, and said lien is in full force and effect; and,

WHEREAS, CECIL F. GREENE AND NANCY S. GREENE has/have made an application to the Party of the Second Part for a loan in the sum of \$ 152,600.00 and said Party of the Second Part is willing to make said loan to the said CECIL F. GREENE AND NANCY S. GREENE, provided they furnish it with a mortgage on the lands described in the aforesaid lien, and the said SOUTHTRUST BANK OF ALABAMA, NATIONAL ASSOCIATION subordinate the above described lien and make the same second and subservient to the mortgage of SOUTHTRUST MORTGAGE CORPORATION; and

WHEREAS, the said Party of the First Part is willing to subordinate its said lien and make the second and subservient to the mortgage of the said Party of the Second Part as an inducement to it to make said loan.

NOW THEREFORE, in consideration of the premises and the further consideration of the sum of \$ -0-, cash in hand paid, the Party of the First Part by the Party of the Second Part, the receipt of which is hereby acknowledged, the said Party of the First Part does hereby agree that the lien of CECIL F. GREENE AND NANCY S. GREENE to SOUTHTRUST BANK OF ALABAMA, N.A. dated SEPTEMBER 14, 1988 and recorded in the Probate Office of SHELBY County, Alabama in BOOK 207, PAGE 158, amended by BOOK 307, PAGE 404, amended again by BOOK 398, PAGE 39-40.

shall be second and subservient to the mortgage of CECIL S. GREENE AND NANCY S. GREENE to SOUTHTRUST MORTGAGE CORPORATION, dated MARCH 23, 1992 and recorded in the Probate Office of SHELBY County, Alabama in BOOK PAGE to secure the sum of \$ 152,600.00, plus interest on the land described therein, and the said lien of the said SOUTHTRUST BANK OF ALABAMA, N.A.

shall be subordinate to the mortgage of SOUTHTRUST MORTGAGE CORPORATION

IT IS FURTHER agreed that should CECIL F. GREENE AND NANCY S. GREENE default in their payments under the terms of the real estate mortgage to SOUTHTRUST MORTGAGE CORPORATION, agrees to notify SOUTHTRUST BANK OF ALABAMA, N. A. P. O. BOX 2554, BIRMINGHAM, AL 35290 of said default prior to taking legal action.
