KNOW ALL MEN BY THESE PRESENTS, that in consideration of Four Hundred Forty Thousand and No/100 (\$440,000.00) Dollars to the undersigned Grantor

M. BYROM CORPORATION

a corporation (herein referred to as Grantor), in hand paid by the Grantees herein, the receipt of which is hereby acknowledged, the said Grantor does by these presents, grant, bargain, sell and convey unto

GARY M. GLASSCOCK AND LINDA E. GLASSCOCK

(herein referred to as Grantees) for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate, situated in Shelby County, Alabama, to-wit:

Lot 34, according to the survey of GREYSTONE - 1st Sector, 1st Phase, as recorded in Map Book 14 Page 91 A & B in the Probate Office of Shelby County, Alabama; being situated in Shelby County, Alabama.

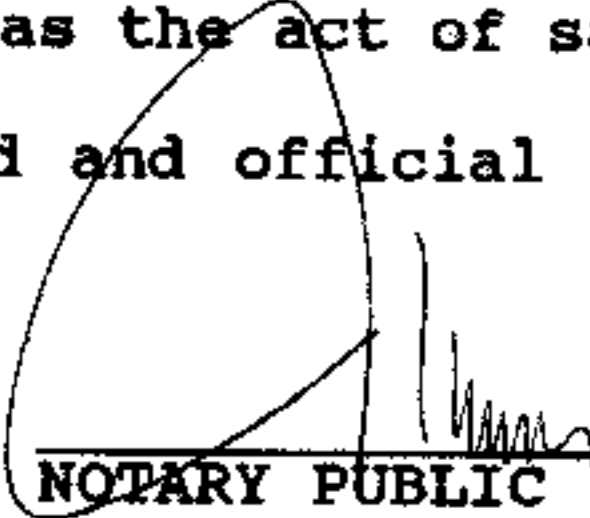
