Begin at the Northeast corner of the NE 1/4 of the SW 1/4 of Section 10, Township 19 South, Range 2 West, Shelby County, Alabama; thence run West along the North line of said 1/4 1/4 Section a distance of 973.61 feet to the Easterly right of way line of a public road; thence turn left 86° 08' 15" and run Southerly along said right of way line a distance of 422.58 feet; thence turn left 94° 01' 55" and run Easterly a distance of 1011.87 feet to the East line of said 1/4 1/4 Section; thence turn left 92° 56' 25" and run North along said 1/4 1/4 Section line a distance of 418.76 feet to the point of beginning; being situated in Shelby County, Alabama.
