CERTIFICATE OF INCORPORATION

OF

DOCUMENT PROCESSING CONVERSION OF ALABAMA, INC.

TO THE HONORABLE JUDGE OF PROBATE OF SHELBY COUNTY, ALABAMA:

The undersigned Albert L. Jackson, Gerald T. Durbin and John W. Logan, each of whom is over the age of twenty-one years, desiring to organize a body corporate under the laws of the State of Alabama, and being all of the subscribers to the capital stock of the corporation hereby organized, do make, sign and file this Certificate of Incorporation as follows:

ARTICLE I

The name of the corporation is: Document Processing Conversion of Alabama, Inc.

ARTICLE II

The nature of the business and the objects and purposes to be transacted, promoted and carried on by the corporation are to do any and all things herein mentioned as fully and to the same extent as natural persons might or could do, and in any part of the word, viz.:

- 1. To sell and service computer and electronic equipment.
- 2. To own, establish, construct, build, lease, buy or otherwise acquire, sell, exchange, transfer, assign, or otherwise dispose of, maintain, operate, or otherwise manage, separately or together, warehouses, offices, shops, buildings, houses, and other facilities in connection with the operation of the business as above described.
- 3. To own, design, erect, build, construct, lease, buy or otherwise acquire, sell, charter, exchange, transfer, assign, convey, or otherwise dispose of, equip, maintain, use, operate, or otherwise manage buildings, garages, warehouses, and all other structures and facilities, equipment and appurtenances incidental, necessary, useful, auxiliary to or convenient for the business and operations conducted, engaged in and carried on by the corporation.

- 4. To purchase, take, own, hold, rent, lease, deal in, mortgage or otherwise pledge, and to lease, sell, exchange, transfer and in any manner whatever dispose of real property, wherever situated.
- 5. To manufacture, purchase or otherwise acquire, and to hold, own, mortgage, pledge, sell, transfer, or in any manner dispose of, and to deal and trade in goods, wares, merchandise and personal property of every class and description wherever situated.
- 6. To acquire the good will, rights, assets and properties, and to undertake the whole or any part of the liabilities of any person, firm, association or corporation; to pay for the same in cash, the stock or other securities of the corporation, or otherwise; to hold, to in any manner dispose of the whole or any part of the property so acquired; to conduct in any lawful manner the whole or any part of the business so acquired, and to exercise all the powers necessary or convenient in and about the conduct and management of any such business.
- 7. To guarantee, purchase, or otherwise acquire, hold, sell, transfer, assign, mortgage, pledge or otherwise dispose of shares of the capital stock, bonds, notes, debentures or other evidences of Indebtedness or securities created by other corporations and similar entities and, while the holder of such securities, to exercise all the rights and privileges of ownership, including the right to vote thereon to the same extent as a natural person might do.
- 8. To purchase or otherwise acquire, hold, use, sell, or in any manner dispose of, and to take or grant licenses or other rights therein and in any manner deal with patents, inventions, improvements, processes, trademarks, trade names, rights and licenses secured under letter patent, copyrights, or otherwise.
- 9. To enter into, make and perform contracts of every kind for any lawful purpose without limit as to amount, with any person, firm, association, or corporation, town, city, county, state territory, government or governmental subdivision.
- 10. To draw, make, accept, endorse, guarantee, discount, execute and issue promissory notes, drafts, bills of exchange, warrants, debentures and other negotiable or transferable instruments.
- 11. To issue bonds, debentures, or other obligations, to secure the same by mortgage, pledge, deed of trust or otherwise.

- 12. To sell, purchase, hold and re-issue the shares of its own capital stock and other securities issued from time to time by it.
- 13. To Lend money upon such security as the Board of Directors of the corporation may deem advisable, or without security.
- 14. To enter into any plan or project, including any legal arrangement for sharing of profits, for the assistance and welfare of its employees.
- 15. To have one or more offices to carry on all of its operations and businesses without restriction or limit as to amount, both within and without this state, other states, districts, territories, possessions or colonies or the United States and in any and all foreign countries, in any lawful manner.
 - 16. To carry on any other business in connection with the foregoing.

In general, to do any and all things herein set forth and such other things as are incidental or conducive to the attainment of the objects and purposes of this corporation as retailer, wholesaler, principle, factor, agent, contractor, or otherwise, either alone or in conjunction with any person, firm, association, corporation or any other entity of whatsoever kind, and to do such acts and things and to exercise any and all such powers to the full extent authorized or permitted to a corporation under any laws that may be now or hereafter applicable or available to this corporation; provided, however, that the corporation shall not engage in the business of insurance, banking, or that of a trust company.

The objects specified herein shall, except where otherwise expressed, be in nowise limited or restricted by reference to interference from the terms of any other particular clause or paragraph hereof, but the objects, purposes and powers specified in each of the clauses and paragraphs hereof shall be regarded as independent objects, purposes and powers, and the enumeration of specific objects, purposes and powers shall not be held or construed to limit or restrict in any manner the general powers now or hereafter conferred on this corporation by the laws of the State of Alabama, nor shall the expression of one thing be deemed to exclude one or more other things not expressed.

ARTICLE III

The location of the corporation's principle office in the State of Alabama shall be at 223 County Road 109, Wilsonville, Alabama 35186.

ARTICLE IV

The total number of shares of capital stock which the corporation shall have authority to issue is five thousand (5,000) shares of common stock, all of the same class and of the par value of ten (\$10.00) dollars per share, and the amount of total authorized capital of the corporation shall be five thousand (\$50,000.00) dollars. The amount of capital stock with which the corporation will begin business is ninety (90) shares of said authorized capital stock of the aggregate value of ten (\$10.00) dollar to be paid for in accordance with the subscription list attached hereto marked Exhibit "A" and incorporated herein by reference.

To the extent of the authorized capital stock, the Board of Directors may issue stock for such consideration, not less that the par value thereof, as may be decided from time to time by the Board of Directors.

ARTICLE V

The period of the duration of the corporation shall be unlimited and perpetual.

ARTICLE VIII

The corporate powers shall be exercised by the Boar do Directors, except as otherwise provided by statute or by this Certificate of Incorporation. In furtherance and not in limitation of the power conferred by statute, the Board of Directors is expressly authorized:

- (a) To make and alter the by-laws of the corporation, but by-laws of made by the directors may be altered or repealed by the directors of stockholders.
- (b) To Fix and determine and to vary the amount of working capital of the corporation; to determine whether any, and if any, what part of any accumulated profits shall be declared and paid as dividends; to determine the date or dates of the declaration and payment of dividends; to direct and determine the use and disposition of any surplus or net profits over and above the capital stock paid in.

The corporation may, in its by-laws, confer powers upon its Board of Directors in addition to the foregoing, and in addition to the powers and authorities expressly conferred upon it by statute.


