

Commence at the NE corner of Section 31, Township 21 South, Range 1 East; thence run West along the North line of said Section a distance of 820.47 feet to a point on the Southwest right of way line of Shelby County Highway No. 28; thence turn an angle of 139 deg. Ø6 min. to the left and run along said right of way of Shelby County Highway No. 28, a distance of 208.71 feet to the point of beginning; thence continue in the same direction a distance of 414.59 feet; thence turn an angle of 91 deg. 30 min. to the right and run a distance of 420.00 feet; thence turn an angle of 89 deg. 00 min. to the right and run a distance of 447.62 feet; thence turn an angle of 100 deg. 04 min. to the right and run a distance of 240.0 feet; thence turn an angle of 10 deg. 34 min. to the left and run a distance of 180.0 feet to the point of beginning.
