I, JESSIE LEE VANDERSLICE, of Saginaw, Shelby County, Alabama, being of sound mind and disposing memory, do make, publish and declare this to be my LAST WILL AND TESTAMENT, revoking all other or former Wills or testamentary dispositions by me at any time heretofore made:

FIRST: I direct that my just debts and funeral expenses be paid as soon after my decease as conveniently can be done.

SECOND: I give, devise and bequeath unto my beloved daughter, Myra Jean Martin, that certain property described in the deed from J. L. Knox to my deceased husband, Eph Vanderslice, said deed being dated March 18, 1948.

THIRD: I give, devise and bequeath unto my beloved daughter, Mildred Ann Sherer, that certain property described in a deed from Evelyn Brummett to Eph Vanderslice and wife, Jessie Lee Vanderslice, said deed being dated May 19, 1961.

It is my intention that all property passing by this Will go to those specified and in the event that one or both of my daughters shall predecease me, then it is my intent that the children of said daughter shall receive said daughter's share under this Will.
