Dollars (\$ 75.00) to 45 in hand paid by Alabama Power Company, a corporation, the receipt whereof is hereby acknowledged, We do hereby grant to said Alabama Power Company, its successors and assigns, the right to cut and trim and to keep cut and trimmed, and remove all timber or other woody growth, including overhanging limbs, within fifteen (15) feet of the strip of right of way described hereinafter on which electric transmission lines of said Alabama Power Company, its successors and assigns, are to be constructed adjacent to grantor(s) land in the

West Half of the Southeast Quarter (W 1/2 of SE 1/4) of Section 11, Township 18 South, Range 1 East, Shelby County, Alabama, such strip of right of way being more particularly described as follows:

To reach the point of beginning of said strip of right of way, commence at the Northeast corner of Section 11, Township 18 South, Range 1 East; thence run West along the North boundary line of said Section 11 a distance of 561.17 feet to a point; thence turn an angle to the left of 77 degrees 06 minutes 28 seconds and run South 13 degrees 37 minutes West a distance of 3648.7 feet to a point; thence turn an angle to the right of 36 degrees 25 minutes and run South 50 degrees 02 minutes West a distance of 517 feet to a point, such point being the point of beginning of the strip of right of way herein described; therefrom, said strip of right of way is ten (10) feet in width and lies five (5) feet on each side of a center line and the continuations thereof which begins at such point of beginning and runs South 50 degrees 02 minutes West a distance of 303 feet to a point, such point being the point of ending of said strip of right of way.

Also, the right to install and maintain anchors and guy wires on lands adjacent to the above described strip of right of way.
