That in consideration of SEVENTY ONE THOUSAND & NO/100---- (\$71,000.00) DOLLARS the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt whereof is acknowledged, we, Mary K. Smith O'Neal and husband, James R. O'Neal, Sr. (herein referred to as grantors), do grant, bargain, sell and convey unto Edward K. Brewer and wife, Donna Ryan Brewer (herein referred to as GRANTEES) for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and and right of reversion, the following described real estate, situated in Shelby County, Alabama, to-wit:
