**ARTICLES OF INCORPORATION**  
**OF**  
**WYNN & ASSOCIATES, INC.**

The undersigned, acting as incorporator of a corporation under the Alabama Business Corporation Act, adopts the following Articles of Incorporation for such Corporation.

**FIRST:** The name of the Corporation is **WYNN & ASSOCIATES, INC.**

**SECOND:** The period of duration of the Corporation shall be perpetual.

**THIRD:** The purpose or purposes for which the Corporation is organized are to lend money and negotiate loans; to finance and aid by loan, subsidy, consignment or otherwise any corporation, association, firm, partnership or entity; to execute and receive any mortgage, security agreement, collateral or otherwise in exchange for issued money or loan; and to repossess by legal process or otherwise for the enforcement of any property rights, liens or interests it may be entitled to receive; and to engage in any lawful act or activity for which corporations may be organized under the Alabama Business Corporation Act.

**FOURTH:** The aggregate number of shares of stock which the Corporation shall have authority to issue is 5000 shares of Common Stock, having a par value of One Dollar (\$1.00) per share.

**FIFTH:** The directors of the Corporation shall have the power to sell any authorized but unissued shares of stock at any time and to any person as they deem advisable, and no shareholder shall be entitled, as of right, to subscribe to or purchase any of such additional shares of stock. No shareholder, by virtue of being a shareholder, shall enjoy any pre-emptive rights with regard to the purchase of any shares of stock of the Corporation.

**SIXTH:** The location and mailing address of the initial registered office of the Corporation are Wynn & Associates, Inc., 8 Brush Creek Farms, Columbiana, Alabama 35051, and the name of its initial registered agent at such address is Elaine W. Beiersdoerfer.

**SEVENTH:** The number of Directors which shall constitute the initial Board of Directors of the Corporation is two (2), and the names and addresses of the persons to serve as the Directors until the first annual meeting of shareholders or until their successors are elected and qualified are:



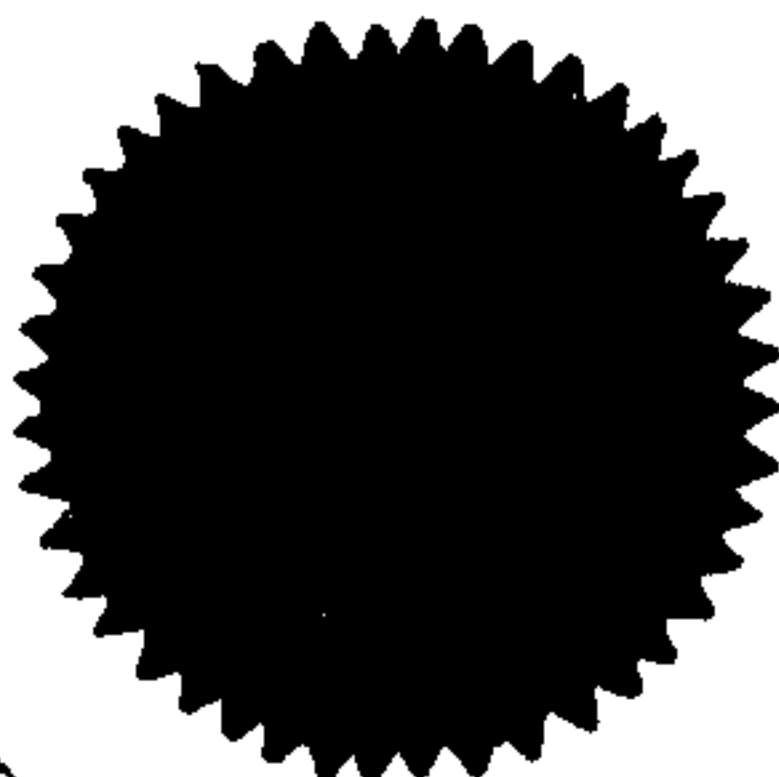
