

# **ARTICLES OF INCORPORATION**

The undersigned, for the purpose of forming a corporation under the Alabama Business Corporation Act, hereby adopt the following Articles of Incorporation;

## **ARTICLE ONE**

### **NAME**

The name of the corporation is **BasCom, Inc.**

## **ARTICLE TWO**

### **DURATION**

The term of existence of the corporation is perpetual.

## **ARTICLE THREE**

### **PURPOSE**

The purposes for which the corporation is organized are to engage in **sale and purchase of telecommunications equipment**; and to engage in any lawful act or activity for which corporations may be organized under the Alabama Business Corporation Act.

## **ARTICLE FOUR**

### **REGISTERED OFFICE**

4.01. The street address of the initial registered office of the corporation is **104 Newgate Road, Alabaster, AL 35007.**

4.01. The initial registered agent at that address is **Mark Woodham Bass.**

## **ARTICLE FIVE**

### **CAPITAL STOCK**

The total number of share that the corporation has authority to issue is **100** shares of common stock with a par value of **One Dollar (\$1.00)** per share.
