That in consideration of SIXTY THREE THOUSAND AND NO/100 DOLLARS (\$63,000.00) to the undersigned grantor in hand paid by the Grantees herein, the receipt of which is hereby acknowledged, **KATHERINE Y. BEITLE and husband, TERRY K. MAPLES**, (herein referred to as Grantors) do grant, bargain, sell and convey unto **KATHERINE BEITLE, TERRY K. MAPLES AND CHARLES C. YORK** (herein referred to as Grantees) as joint tenants, with right of survivorship, the following described real estate, situated in the State of Alabama, County of Shelby, to-wit:

Lot 3, according to the Survey of Navajo Hills, Fourth Sector, as recorded in Map Book 5, Page 95, in the Office of the Judge of Probate of Shelby County, Alabama.

Subject to existing easements, restrictions, set back lines, rights of ways, limitations, if any, of record.

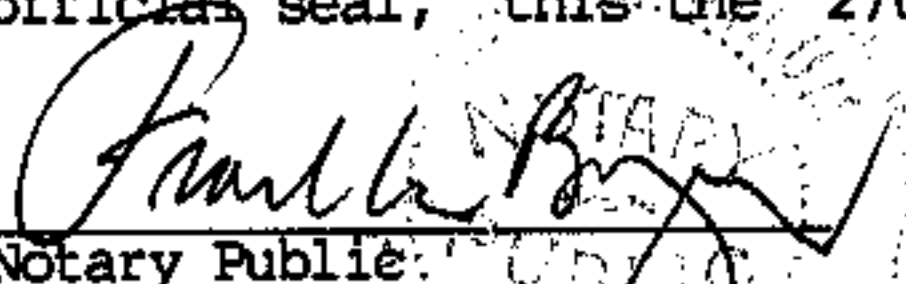
