EXHIBIT A - LEGAL DESCRIPTION

Being a part of the Southwest 1/4 of the Southwest 1/4 and the Southeast 1/4 of the Southwest 1/4 of Section 4, Township 20 South, Range 1 West, Shelby County, Alabama, and being described as follows:

Begin at the Southwest corner of the Southeast 1/4 of the Southwest 1/4 of Section 4, Township 20 South, Range 1 West, thence proceed North along the West line of said 1/4-1/4 section a distance of 498.28 feet to an iron pin being the point of beginning; thence turn a field angle of 88 degrees 45 minutes to the left and proceed a distance of 297.88 feet to an iron pin; thence turn an interior angle of 72 degrees 21 minutes 40 seconds to the right and run a distance of 532.21 feet to an iron pin; thence turn an interior angle of 169 degrees 30 minutes 31 seconds to the right and proceed a distance of 208.80 feet to an iron pin located on the southerly right of way of Shelby County Highway No. 39; thence turn an interior angle of 88 degrees 53 minutes 22 seconds to the right and proceed along the Southerly right of way of County Road No. 39 a distance of 56.61 feet to an iron pin; thence continue along the southerly right of way of county Road #39 a distance of 262.81 feet to an iron pin located in a concrete monument; thence turn an interior angle of 99 degrees 44 minutes 00 seconds to the right and proceed a distance of 296.26 feet to a concrete monument; thence turn an interior angle of 171 degrees 54 minutes 14 seconds to the right and proceed a distance of 296.99 feet to the point of beginning.
