That said Clint Hurt & Associates, Inc. claims a lien upon the following properties, situated in Shelby County, Alabama, to wit:

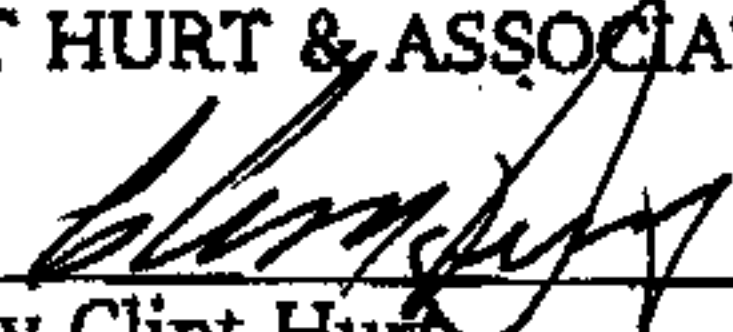

This lien is claimed, separately and severally, as to both the said land and the improvements thereon, including the described well and the leases comprising the unit for such well.

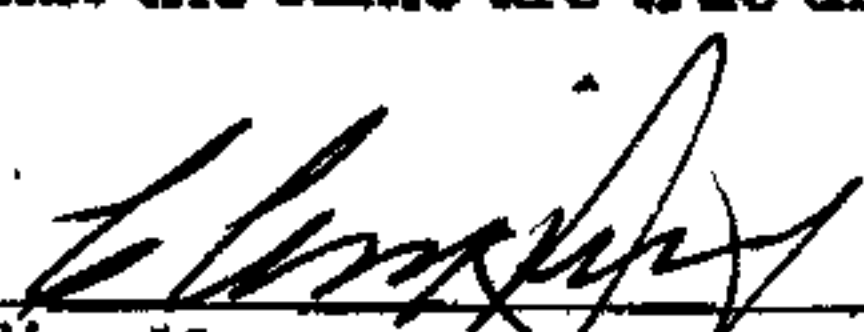
That said lien is claimed to secure the indebtedness set forth in Exhibit A, plus interest and attorneys' fees, for drilling and related services performed at said wells.
