ARTICLES OF AMENDMENT

TO THE

CHARTER

SHONEY'S SOUTH, INC.

Pursuant to Section 48-20-106 of the Tennessee Business Corporation Act of the State of Tennessee, the undersigned corporation adopts the following articles of amendment to its charter.

- The name of the corporation is SHONEY'S SOUTH, INC., a Tennessee corporation (the "Corporation").
 - 2. The text of the amendments adopted are as fol-

lows:

*FIRST: Article FIRST of the Charter of the Corporation is hereby amended to read in its entirety as set forth below:"

FIRST, The name of the Corporation is TPI Restaurants, Inc. (hereinafter the "Corporation").

SECOND: Article SECOND of the Charter of the Corporation is hereby amended to read in its entirety as set-forth below:

> "SECOND: The total number of shares of stock which the Corporation shall have authority to issue is 1,000 shares of Common Stock, each having a par value of one penny (\$.01), and 10,000 shares of Preferred Stock, each having a par value of one penny (\$.01).
