DEFAULT JUDGMENT

The above-styled matter having become in default on April 6, 1992, by the failure of defendant to file his answer or other defensive pleadings, and 15 days having elapsed from the date of default and the default not having been opened as a matter of right or by order of the Court; and, it being made to appear to the Court from the allegations of the complaint that the plaintiffs, J.
