The undersigned, who is duly licensed to practice dentistry in the State of Alabama, for the purpose of forming a professional corporation under the Alabama Business Corporation Act and the Revised Alabama Professional Corporation Act hereby adopts the following Articles of Incorporation:

1. NAME: The name of the corporation is:

- 2. <u>DURATION</u>: The term of existence of the corporation is perpetual.
- 3. PURPOSE: The purposes for which this is corporation is organized are:
- (a) To engage in and carry on all branches of the practice of dentistry, and to do those things that are necessary or proper in connection with that practice, and other related business.
- (b) To purchase, lease, or otherwise acquire, to own, hold, and operate, and to sell, mortgage, pledge, lease, employ, or otherwise dispose of, encumber, or invest in such real estate, mortgages, stocks, bonds, and all types of personal property, tangible or intangible, as may be reasonably required in the conduct of its professional business and in connection with any other proper business activity in which the corporation may engage.


