

ORDINANCE 92-006

An ordinance to alter, rearrange and extend limits of the Town of Wilsonville, Alabama, so as to embrace and include within the corporate limits of said Town all within such corporate limits and also certain other territory contiguous to said Town.

WHEREAS, there is attached to the said petition a map of said territory showing its relationship to the corporate limits of the Town, and

WHEREAS, this Council has determined and found that the matters set forth and alleged in the said petition are true and that it is in the public interest that said property be annexed into the Town of Wilsonville;

NOW THEREFORE, be it ordained by the Council of the Town of Wilsonville as follows:

Section 1: That said Council hereby assents to the annexation of said territory of the Town of Wilsonville, Alabama, and the corporate limits of the Town of Wilsonville, Alabama, and the corporate limits of the Town of Wilsonville are hereby extended and rearranged pursuant to the provisions of Section 11-41-5, Code of Alabama, 1975, so as to embrace and include said territory, in addition to the territory already within its present corporate limits, within the corporate area of said Town, which said territory is not within the corporate limits or municipal boundaries of another municipality and does not lie at any point more than one-half the distance between the present corporate limits and the corporate limits of any other municipality. Said property is described in Exhibit A, attached hereto and made a part hereof.

Section 2. The Town Clerk shall file a certified copy of this ordinance containing an accurate description of said annexed territory with the Probate Judge of Shelby County, Alabama, and also cause a copy of this ordinance to be posted in three places (Post Office, Bank and Service Station) in lieu of a newspaper.

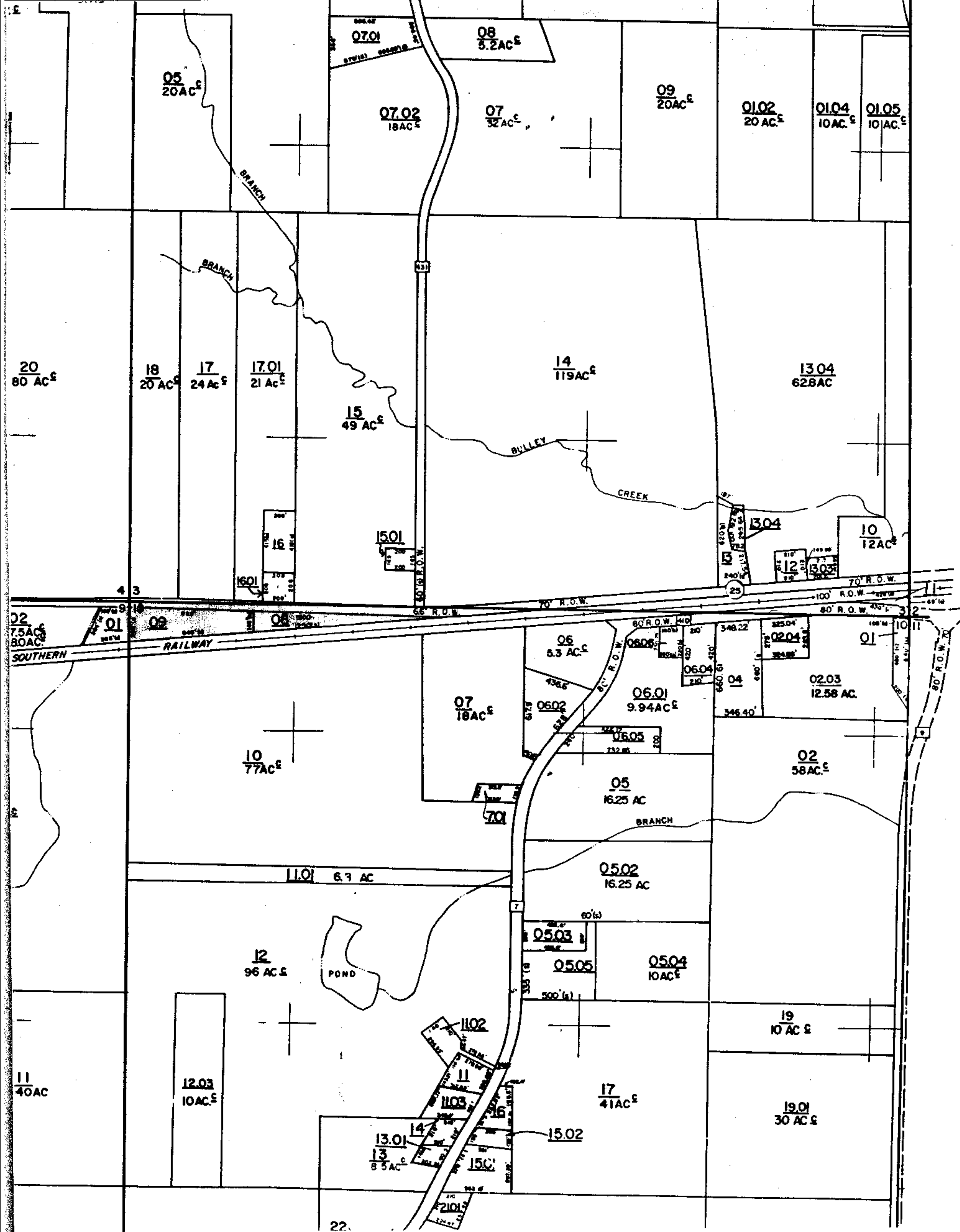
