DESCRIPTION OF PROPERTY

Part of Lot 1 and Plat A, according to the map of R. B. Jones and wife, Jessie T. Jones, as recorded in Map Book 4, page 69, Judge of Probate Office of Shelby County, Alabama, more particularly described as follows: Begin at the Southwest corner of said Lot 1, and run in a Southeasterly direction and along the most Southerly line of said Lot 1 a distance of 240.34 feet; thence turn an angle to the left of 86 deg. 22 min. in a Northeasterly direction a distance of 212.51 feet to a point on the North line of said Plat A; thence turn an angle to the left of 121 deg. 13 min. in a Westerly direction a distance of 244.08 feet to the West corner of said Plat A, said point being on the Northeast right-of-way line of County Road; thence turn an angle to the left of 41 deg. 24 min. in a Southwesterly direction along said road right-of-way line said line being also the Westerly line of Lot 1 for a distance of 71.1 feet to a point of beginning of a curve to the left, said curve having a radius of 2219.95 feet and a degree of 7 deg. 03 min.; thence run along said curve in a Southwesterly direction and along said road right-of-way line and the Westerly line of Lot 1 a distance of 35.0 feet to the point of beginning; being situated in Shelby County, Alabama.
