COMES the Petitioner, and moves the Court to amend the Petition previously filed in this action with reference to Item D, to dismiss that portion of the Petition which relates to Tract Number 22, Estate of Kathleen Elizabeth Wyatt, deceased and substitutes therefore Tract Number 22-A, the property of Earl V. Baker, and described as follows, to-wit: and as shown on the right-of-way map of Project No. F-214(29) as recorded in the office of the Judge of Probate of Shelby County, Alabama:

Commencing at the southeast corner of the SW 1/4 of SW 1/4, Section 28, T-19-S, R-2-E; thence northerly along the east line of said SW 1/4 of SW 1/4 a distance of 974 feet, more or less, to the present southwest right-of-way line of U. S. Highway No. 280; thence northwesterly along said present southwest right-of-way line a distance of 37 feet, more or less, to the southeast line of the property herein to be conveyed and the point of beginning; thence southwesterly along the southeast property line a distance of 64 feet, more or less, to a point that is 100 feet southwesterly of and at right angles to the centerline of Project No. F-214(29); thence N 76° 51' 30"W, parallel with the centerline of said project a distance of 210 feet, more or less, to the northwest property line; thence northeasterly along said northwest property line a distance of 70 feet, more or less, to the present southwest right-of-way line of said highway; thence southeasterly along said present southwest right-of-way line a distance of 210 feet, more or less, to the point of beginning.


