PETITION FOR REFUND, PARCEL NO. 33

Comes now the Petitioner in the above entitled cause and shows unto the Court that the property more particularly described or designated as Parcel No. 33 of Paragraph 3 of the Application for Order of Condemnation, as amended, heretofore filed in said cause, has been, since the filing of the written Report of Commissioners in said cause, purchased from and conveyed by the owner thereof, Carrie Hill, a party respondent to this said cause, to Petitioner, and that Petitioner has paid to said owner the sum of \$140.00, which is the amount of damages and compensations ascertained and assessed by the commissioners in said written report, as the purchase price for said property, as shown by the right-of-way deed recorded at page 179 of Deed Book 204, Office of Judge of Probate, Shelby County, Alabama.

Petition shows unto the Court that the persons designated as owners of Parcel No. 33 in said Application (other than said Carrie Hill) were believed to be the heirs at law of Rubin Hill, but that since the filing of said Application, Petitioner learned that said Rubin Hill and Carrie Hill conveyed said property in 1951 to Willie R. Hill and Jimmy Lee Edwards, as shown at page 181 of Deed Book 204, and that said Willie R. Hill and Jimmie Lee Edwards subsequently conveyed said property to said Carrie Hill, as shown at page 183 of Deed Book 204, and that hence, said Carrie Hill was entitled to <sup>full</sup> payment for said property, said heirs of Rubin Hill having no interest therein.

Petitioner further shows unto the Court that by reason of the above stated facts, Petitioner is entitled to be refunded by the Court the sum of \$140.00 which has been paid into the Court by the Petitioner for said above specified property, purchased by the Petitioner, as aforesaid.

THE PREMISES CONSIDERED, the Petitioner petitions this Court to refund to the Petitioner the sum of \$140.00.
