

ARTICLES OF INCORPORATION
OF
SOUTHEASTERN CHALLENGER, INC.
A BODY CORPORATE

TO THE HONORABLE JUDGE OF PROBATE OF SHELBY COUNTY, ALABAMA:

The undersigned, James O. House, III, acting as incorporator of a corporation under the Code of Alabama, adopts the following Articles of Incorporation for such corporation:

1. The name of the corporation shall be Southeastern Challenger, Inc., and the corporation shall be authorized to operate under that name or use any other trade name not now being used by another person, firm or corporation.

2. The purpose for which the corporation is formed is to transact any and all lawful business for which corporations may be incorporated under the laws of the State of Alabama, including the sale of light and ultra light airplane kits.

3. The location of the initial registered office of the corporation shall be 2065 Shelby County Highway 87, Saginaw, Alabama 35137, and the name of its initial registered agent at that address is James O. House, III.

4. The authorized capital stock of the corporation shall be Five Hundred (500) Shares having a par value of One and No/100 (\$1.00) Dollar per Share. The paid-in capital with which the corporation shall begin business shall be Five Hundred and No/100 (\$500.00) Dollars.


