The undersigned, McKenzie Methane Corporation, files this statement in writing, verified by the oath of Michael McKenzie, its President, who has personal knowledge of the facts herein set forth:

1. That said McKenzie Methane Corporation ("McKenzie"), a Texas corporation, the address of which is 5847 San Felipe Road, Suite 4300, Houston, Texas 77057, is a party to a certain Operating Agreement (the "Operating Agreement") dated effective as of March 17, 1989, with KUKUI, Inc., as successor in interest to Smith-Gordy Methane Company, a Texas joint venture composed of Lester H. Smith and Russell D. Gordy ("KUKUI"), the address of which now is KUKUI, Inc., Kawaiahao Plaza, 567 South King Street, Suite 328, P.O. Box 3466, Honolulu, Hawaii 96801, Attention: Mr. Nathan T.K. Aipa, Vice President and General Counsel. It is believed that KUKUI, Inc. has assigned its rights, titles and interests in the properties subject to the Operating Agreement, to HAK Partners I, II, III, IV and V, which assignment has not been recorded. To the extent such an assignment has been made, the liens referenced herein shall attach to the interests so assigned. A Memorandum of Development Agreement and Financing Statement describing the principal terms of the Operating Agreement was filed in the Real Property Records of Shelby County, Alabama, at Book 239 Page 669 on May 23, 1989.

2. That, under the Operating Agreement, said McKenzie was appointed by KUKUI as "Operator" with respect to the development and production of coalbed gas and occluded gas from coal seams and other minerals from the lands covered by certain leases and contracts described in Exhibit A hereto (the "Contract Area").

3. That, in connection with the performance of its obligations under the Operating Agreement and the agreements related thereto, McKenzie has performed labor and supplied materials used in the construction, operation, maintenance and repair of facilities for the production of gas and other minerals on the properties in the Contract Area.

4. That, under the Operating Agreement, KUKUI granted to McKenzie a lien upon all of its coalbed gas, occluded gas and other mineral leasehold rights in the Contract Area, and a security interest in its share of coalbed gas, occluded gas and other minerals when extracted and in its interest in all equipment on the Contract Area, to secure the payment by KUKUI of its share of costs and expenses, together with interest thereon at the rate provided in the Operating Agreement and the agreements related thereto.

5. That, in addition to and without prejudice to the contractual lien described above or any other remedy in law or in equity which may be available to it, McKenzie claims a further lien, pursuant to §35-11-210 of the Code of Alabama, upon all of KUKUI's right, title and interests in and to the property listed on Exhibit B and situated in Shelby County, Alabama. This lien is claimed, separately and severally, as to both the buildings and improvements thereon, and the said land.




