That in consideration of THIRTY TWO THOUSAND & NO/100---- (\$32,000.00) DOLLARS to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt whereof is acknowledged, we, Patricia Elizabeth Anderson and husband, David Anderson (herein referred to as grantors), do grant, bargain, sell and convey unto Charles Kelley and wife, Shirley Kelley (herein referred to as GRANTEES) for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and and right of reversion, the following described real estate, situated in Shelby County, Alabama, to-wit:



Subject to existing easements, current taxes, restrictions, set-back lines and rights of way, if any, of record.
