STATEMENT OF LIEN

Alabama Classic Homes Inc., files this statement in writing, verified by the oath of Jim McBrayer, who has personal knowlege of the facts setforth herein:

1. That the said Alabama Classic Homes, Incorporated claims a lien upon the following property, situated in Shelby County, Alabama, to-wit:

In the NE 1/4 of the NW 1/4 of Section 11, Township 21 South, Range 3 West, begin at the intersection of the Easterly right-of-way line of Mill Street and the Southerly right-of-way line of 4th Avenue West as shown on the Map of the Dedication of the Streets and Easements, Town of Siluria, Alabama, thence Northeasterly along said right-of-way line of 4th Avenue for 200.66 feet, thence 105° 19' right and run Southerly for 342.68 feet, thence 91° 15'45" right and run Westerly for 179.39 feet to a point of the Easterly right-of-way line of Mill Street, thence 88° 23'45" right and run Northerly along said right-of-way line of Mill Street for 196.60 feet to the beginning of a curve to the left, said curve having a radius of 325.36 feet, thence continue Northerly along said right-of-way line of Mill Street and along the arc of said curve for 90.36 feet to the Point of Beginning.

Said tract being more particularly described as follows: Lot 18 according to the Map of the Town of Siluria, recorded in Map Book 5 on Page 10 in the Office of the Judge of Probate of Shelby, County, Alabama.

This lien is claimed, seperately a severally, as to both the buildings and improvements thereon, and as to the said land.

2. That the said lien is claimed to secure an indebtedness of \$ 9,029.00 plus attorneys fees and interest thereon. Said interest being due from the first day of July, 1992.

3. That said indebtedness is for physical improvements done on said land and buildings contained thereon together with materials and work and labor supplied thereon.
