**WARRANTY DEED, JOINTLY FOR LIFE WITH REMAINDER TO SURVIVORS**

STATE OF ALABAMA )  
SHELBY COUNTY ) **KNOW ALL MEN BY THESE PRESENTS:**

That in consideration of Fifty Thousand and No/100 Dollars (\$50,000.00) to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt of which is acknowledged, I, RANDALL H. GOGGANS, a married man (herein referred to as GRANTORS) do grant, bargain, sell and convey unto HAROLD E. LOCKHART, SR. and MARY NELL LOCKHART (herein referred to as GRANTEES) for and during their joint lives and upon the death of either of them, then to the survivors of them in fee simple, for and during the joint lives of the survivors, and upon the death of either of the survivors, then to the survivor of the survivors in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated in Shelby County, Alabama to-wit:

Lot 8, according to the survey of Brookshire, Second Sector, a private, single family, residential, estate lot, subdivision, as recorded in Map Book 16, Page 65 in the Probate Office of Shelby County, Alabama; being situated in Shelby County, Alabama.


SUBJECT TO: (1) Taxes due in the year 1993 and thereafter. (2) Building setback line of 50 feet reserved from Street as shown by plat. (3) Restrictions, covenants and conditions as set out in instrument(s) recorded in Instrument No. 1992-12759 and Map Book 16, Page 65. Said map shows the subdivision to be a private single family residential estate lot subdivision.

The property conveyed herein is not the homestead of the Grantor.


