

ASSIGNMENT OF MORTGAGE



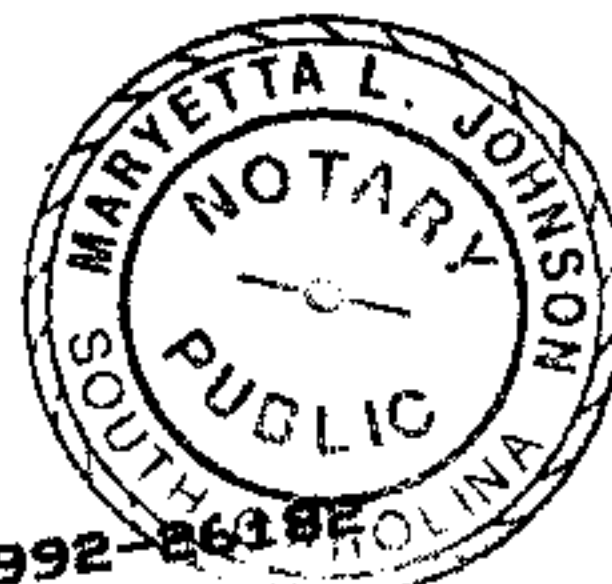
