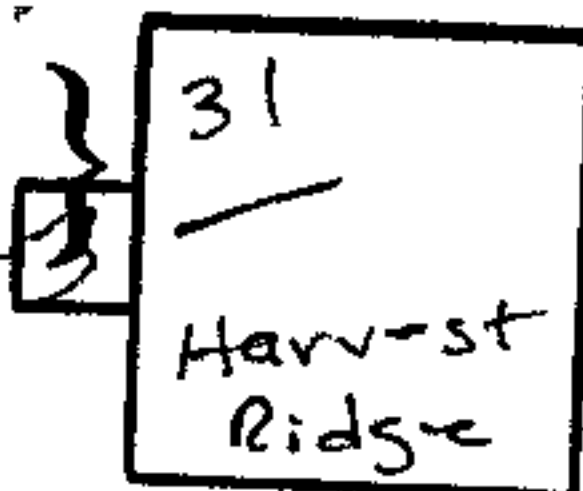


EASEMENT — OVERHEAD AND UNDERGROUND

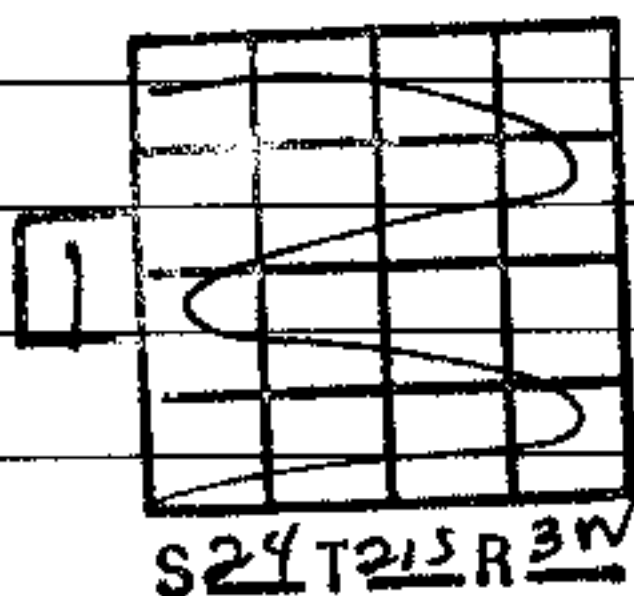

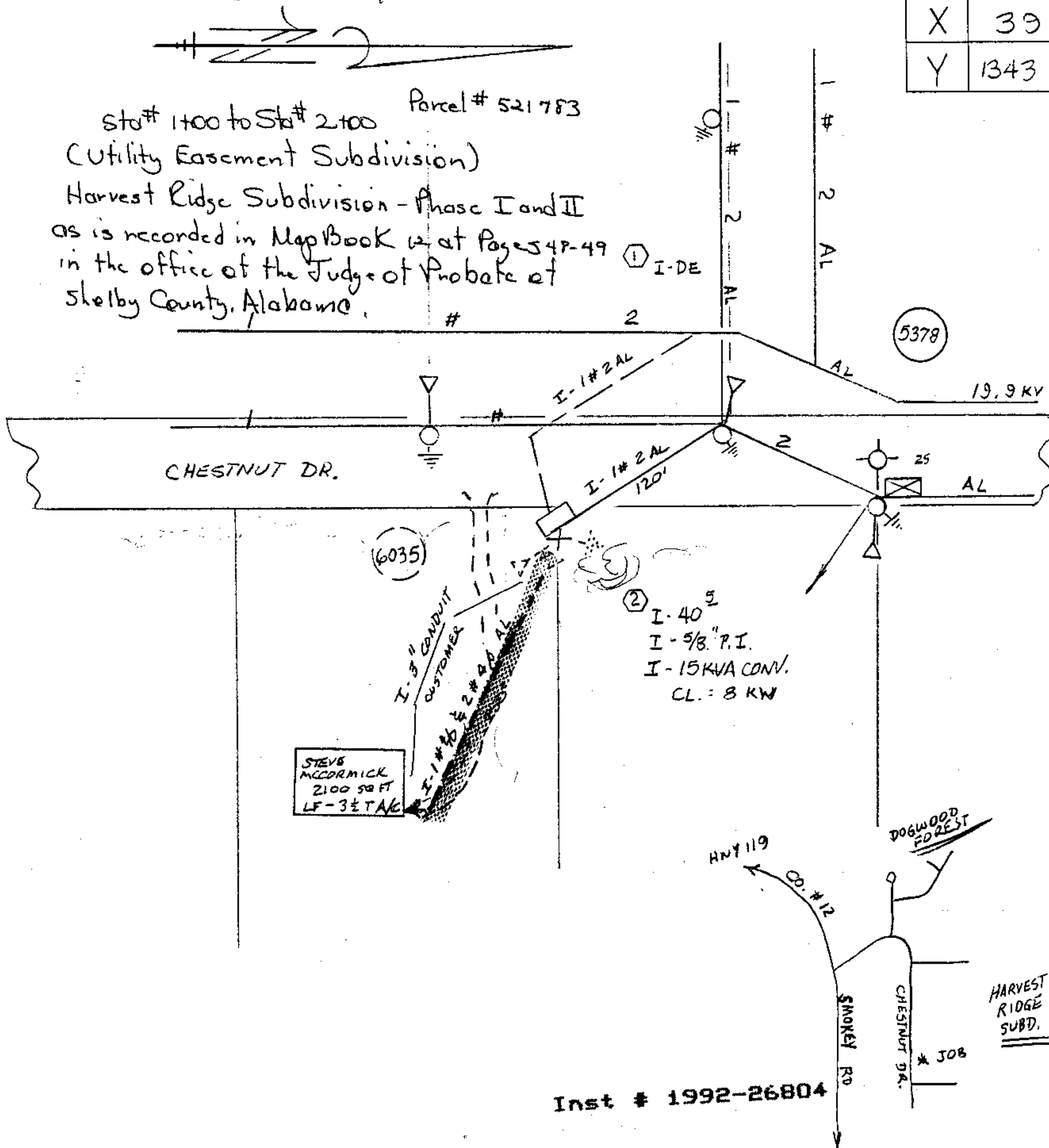
