

DELEGATION OF POWERS BY PARENTS

KNOW ALL MEN BY THESE PRESENTS, that in accordance with Section 26-2A-7, CODE OF ALABAMA, 1988, we, EUGENE J. BARTON and PAULINE N. BARTON, of the City of Los Angeles, County of Los Angeles, California, the natural parents of MARI C. BARTON age 14, born on the 14 day of JUNE, 1978, do hereby constitute and appoint THOMAS M. GREANEY and JANE BARTON GREANEY of 2828 Berkeley Drive, Birmingham, Alabama 35242-4100, Shelby County, Alabama, GUARDIAN of our child, MARI C. BARTON. The GUARDIAN shall have the custody and power to consent to the following:

ENROLL HER IN SCHOOL, OBTAIN MEDICAL CARE, TAKE HER ON VACATION, FISHING, BOAT RIDING, BICYCLE, AMONG OTHER ACTIVITIES.

It is our intentions that the GUARDIAN shall have all the powers of the heretofore stated except the power to consent to marriage or adoption of our child, for a period not exceeding one year from the date hereof. We further understand that this temporary "delegation" of our parental powers does not relieve us of the primary responsibility of our child.

GIVING AND GRANTING unto said GUARDIAN full power and authority to do, take and perform all and every act and thing whatsoever requisite, proper or necessary to be done, in the exercise of any of the rights and powers herein granted, as fully to all intents and purposes for the benefit of our child, MARI C. BARTON, as we might or could do if personally present, hereby ratifying and confirming all that the said GUARDIAN shall lawfully do or cause to be done by virtue of this delegation of powers and the rights and powers herein granted.


