David A. Diestelhorst

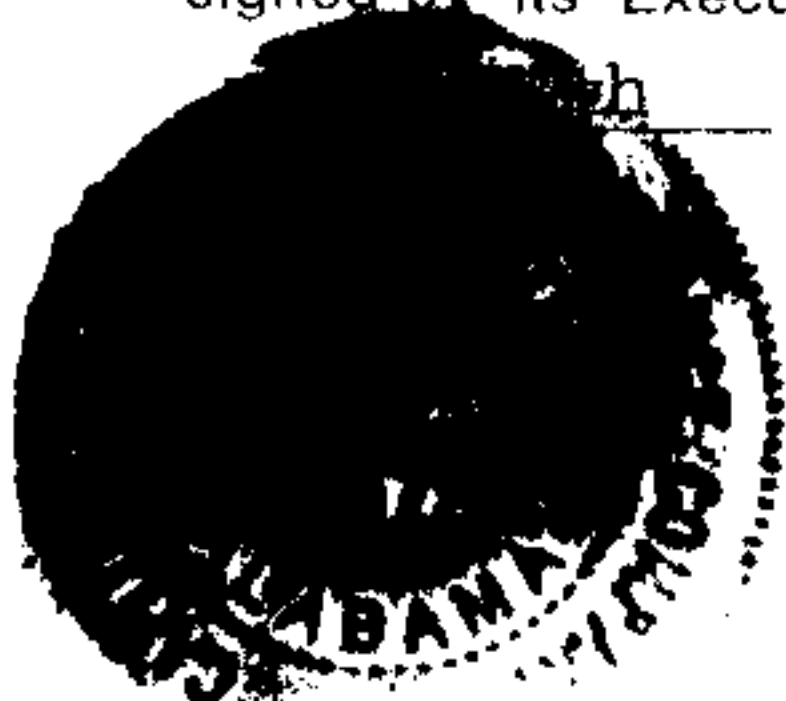

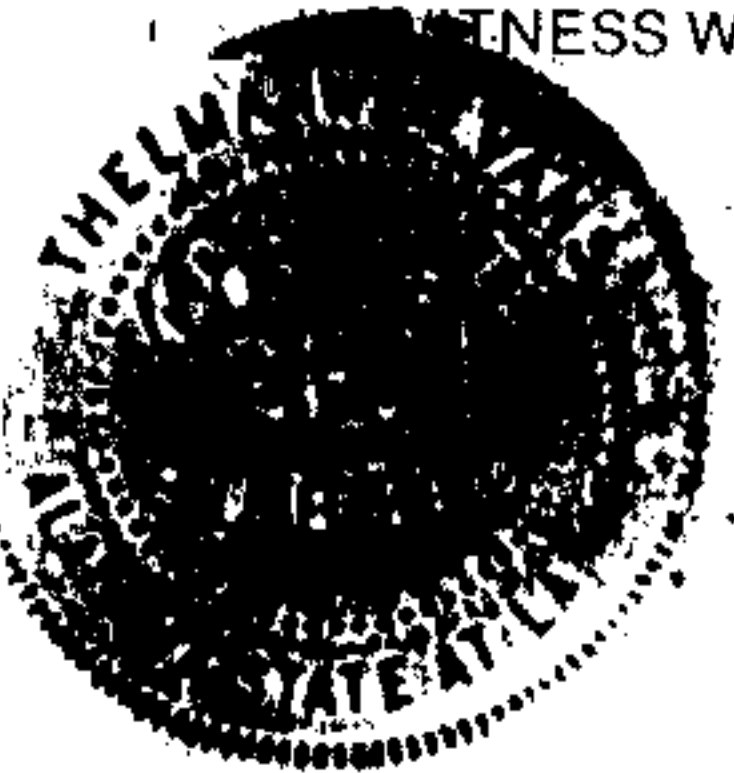
