

AMENDMENT TO CERTIFICATE AND AGREEMENT
OF LIMITED PARTNERSHIP
OF

We the undersigned, amend the Certificate and Agreement of Limited Partnership of Buck-A-Woo Partnership, Ltd. filed October 13, 1992 on the office of the Judge of Probate of Shelby County, Alabama for the following reasons and in the following manner:

Therefore, the relevant provisions of the Certificate and Agreement of Limited Partnership of BUCK-A-WOO PARTNERSHIP, LTD. shall be amended to read as follows:

"1.4 Partners' Names and Mailing Addresses: The names and mailing addresses of the General Partners are set forth in Section 4.1. 4.2 Limited Partners: The Fiorella Family Partnership, Ltd; Buck, Ltd. and Jack Fiorella, Jr. and Peggy Fiorella are hereby named as the Limited Partners of the Limited Partnership and shall upon the filing of this Certificate and Agreement of Limited Partnership contribute in cash to the capital of the Limited Partnership in the amounts set forth in Section 5 below. The names and mailing addresses of the Limited Partners are: The Fiorella Family Partnership, Ltd., 2672 Dolly Ridge Road, Birmingham, Alabama 35243; Buck, Ltd., 2908 Monte D'este Dr., Birmingham, Alabama 35216; and Jack Fiorella, Jr. and Peggy Fiorella, 1455 Badham Dr., Birmingham, Alabama 35216.

5.1 Profits, Losses and Distributions: All profits and losses derived from the Limited Partnership, and each item of income, gain, loss deduction and credit entering into the computation thereof, shall be allocated to the Limited Partners and the General Partners as follows:


