KNOW ALL MEN BY THESE PRESENTS: That, David M. Denson and wife, Cynthia W. Denson did, on to-wit, the 21st day of March, 1986, execute a mortgage to MortgageAmerica, Inc., which mortgage is recorded in Real Volume 66, Page 647 and re-recorded in Real Volume 68, Page 395 which said mortgage was duly transferred and assigned to National Mortgage Company by instrument recorded in Instrument #1992-22544 et seq., in the Office of the Judge of Probate of Shelby County, Alabama; and

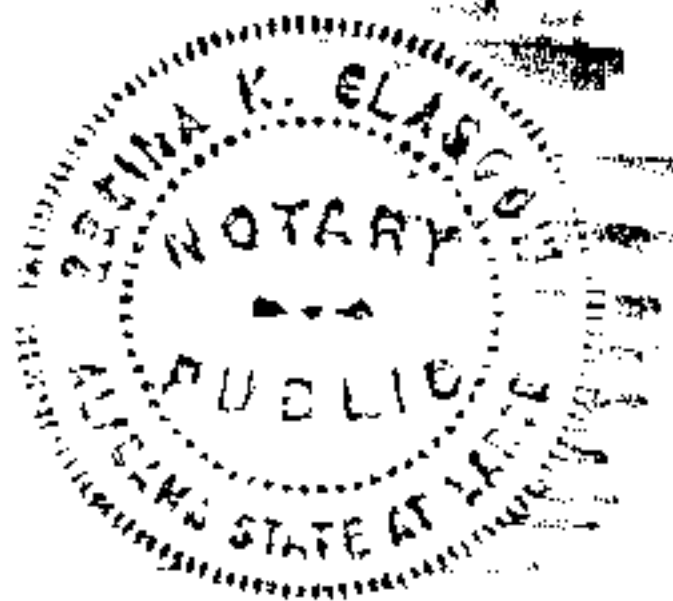
