SUBORDINATION AGREEMENT

This Subordination Agreement, made and entered into on this the 2nd day of March, 1992, by and between AMSOUTH BANK, N.A., as party of the FIRST PART, and AMOUTH MORTGAGE COMPANY, as party of the SECOND PART,
