ARTICLES OF AMENDMENT
TO THE ARTICLES OF INCORPORATION

Article I

The name of the corporation is:

Brandon-David Corporation

Article II

The following amendment was adopted in the manner provided by the Alabama Business Corporation Act:

In an effort for the corporate name to better reflect the general purpose of the corporation, that the corporate name be changed from Brandon-David Corporation to AIP Corporation.

Further, to change the principal office of the corporation to 731 Logan Road, Suite 104, Clanton, Alabama 35045.

Further to change the name and post office address of the agent designated by the incorporators to receive subscriptions to the capital stock to Bret Lawson, 731 Logan Road, Suite 104, Clanton, Alabama 35045.

Further to change to name and post office address of the registered agent Bret Lawson to 731 Logan Road, Suite 104, Clanton, Alabama 35045.

Article III

The amendment was adopted by the shareholders or directors in the manner prescribed by law on November 3, 1992.
