
1. The name of the corporation is Four Square Properties Roberts Real Estate, Inc.

2. A statement of intent to dissolve the corporation has heretofore been filed on the 30 day of December, 1992.


3. All known debts, obligations and liabilities of the corporation have been paid and discharged, or adequate provisions have been made therefor.
