WHEREAS on August 20, 1992, the Resolution Trust Corporation ("RTC") was appointed as Receiver (the "Receiver") for Birmingham Federal Savings and Loan Association (the "Association") by the Office of Thrift Supervision ("OTS") by OTS Order No. 92-360 pursuant to Section 5 (d) (2) (H) (ii) of the Home Owner's Loan Act of 1933 ("HOLA"), as amended by Section 301 of the Financial Institutions Reform, Recovery and Enforcement Act of 1989;

WHEREAS on August 21, 1992, the Receiver entered into a Purchase and Assumption Agreement with Birmingham Federal Savings Bank (the "Bank") which agreement transferred certain of the assets of the Association to the Bank;

WHEREAS on August 21, 1992, the OTS by Order No. 92-360 appointed the RTC as Conservator for the Bank;
