## AMENDMENT TO CONDEMNATION PROCEEDING





and as shown on the right-of-way map of Project No. P-214(19) as recorded in the Office of the Judge of Probate of Shelby County, Alabama:

Commencing at the southeast corner of the SW $\frac{1}{4}$  of NE $\frac{1}{4}$ , Section 5, T-19-S, R-1-W; thence westerly along the south line of said SW $\frac{1}{4}$  of NE $\frac{1}{4}$ , the south property line, a distance of 650 feet, more or less, to a point that is northerly of and at right angles to the traverse of a dirt road at Station 17+00 and the point of beginning of the property herein to be conveyed; thence continuing westerly along said south property line (crossing the centerline of Project No. P-214(19) at approximate station 231+98) a distance of 329 feet, more or less, to the present northeast right-of-way line of U. S. Highway No. 280; thence northwesterly along said present northeast right-of-way line, a distance of 996 feet, more or less, to the north property line; thence easterly along said north property line (crossing the centerline of said project at Station 222+01.6) a distance of 178 feet, more or less, to a point that is 150 feet northeasterly of and at right angles to the centerline of said project; thence S 7° 26' 41" E, parallel to the centerline of said project, a distance of 900 feet, more or less, to a point that is 150 feet northeasterly of and at right angles to the centerline of said project at Station 231+25; thence southeasterly along a straight line, a distance of 161 feet, more or less, to a point that is 70 feet northerly of and at right angles to the traverse of said dirt road at Station 17+00; thence southerly along a straight line (which if extended would intersect the traverse of said road at Station 17+00) a distance of 63 feet, more or less, to the point of beginning.
