This cause coming on to be heard on this day for a decree confirming the report of the commissioners heretofore appointed in this cause, and for an order of condemnation in pursuance thereof as to the lands, easements, rights and interests described in the application heretofore filed in this cause;

And it appearing to the Court that on, to-wit, the 29th day of January, 1974, this Court heard the allegations of said application as to the parties and lands named and described of said application and all legal evidence offered by the parties touching the same, and did thereafter make an order granting said application, for the condemnation of certain lands, easements rights and interests therein described, and did also in and by said order and decree appoint A. M. Muncy, J. B. Turner, Jr., and L. C. Franks, three citizens of said County of Shelby, in which county the lands and rights sought to be condemned are situated, possessing the qualifications of jurors and who are disinterested, to assess the damages and compensation to which the owners of the land described are entitled;

And it further appearing to the Court that notice of the appointment of said three named persons as commissioners was issued by this court within the required five days;

And it further appearing to the Court that said commissioners, before enterreing upon the discharge of their duties in the premises, were sworn as jurors are sworn, and that they did thereafter receive all legal evidence offered by the parties touching the amount of damages the owners of, or the owners of an interest in, said land will sustain and the amount of compensation they are entitled to receive;

And it further appearing to the Court that said commissioners did on, to-wit, the 7th day of February, make their report in writing to the Court, stating the amount of damages and compensation ascertained and assessed by them for the owners of, or the owners of an interest in, the lands as described in the application as follows:

To Britt Ingram, owner of Tract # 1, Parcel # 1,  
the award was \$37,500.00

To Clarence Hebb and Louise S. Hebb, owners of Parcel # 2,  
Tract # 5, the award \$7,500.00

To Margie Studemire, owner of Tract # 8, Parcel # 3,  
the award \$200.00

To Mrs. R. G. Weaver, owner of Tract # 11, Parcel # 4,  
the award \$53,500.00

To Marvin Weaver Johnson and Marth Jean Johnson, owners  
of Tract # 15A, Parce # 5, award \$500.00.

And it further appearing to the Court that said commissioners did also file a certificate along with their award that none of them had ever been consulted, advised with or approached by any person in reference to the value of the lands or the proceedings to condemn the same prior to the assessment of damages and that they knew nothing of the same prior to their appointment;

It is further ORDERED, ADJUDGED AND DECREED by the Court that the applicant, STATE OF ALABAMA, pay all costs incurred in this cause.

It is therefore, ORDERED, ADJUDGED AND DECREED by the Court that the said report of commissioners be and the same is hereby ordered to be recorded, together with said application and all the orders and decrees made in this cause and the pleadings filed herein.

And it further appearing to the satisfaction of the Court that all things necessary and required by Title 19, Chapter 1, of the Code of Alabama of 1940, as amended, have been done and performed by the applicant.;

And it is further ORDERED, ADJUDGED AND DECREED by the Court that applicant be and it is hereby granted all the relief, rights, interest easements and privileges set out, described and prayed for in said application.
