PARCEL NO. SIX

Commencing at the southwest corner of the NE 1/4 of SE 1/4, Section 30, T-19-S, R-2-W; thence northerly along the west line of said NE 1/4 of SE 1/4, a distance of 990 feet, more or less, to a point that is 110 feet southeasterly of and at right angles to the centerline of Shelby County Road No. 17 and the point of beginning of the property herein to be conveyed; thence continuing northerly along the west line of said NE 1/4 of SE 1/4, the west property line, a distance of 87 feet more or less, to the present southeast right-of-way line of said road; thence northeasterly along said present southeast right of way line, a distance of 381 feet, more or less, to the north line of said NE 1/4 of SE 1/4, the north property line; thence easterly along said north property line, a distance of 111 feet more or less, to a point that is 110 feet southeasterly of and at right angles to the centerline of said road; thence southwesterly, parallel to the centerline of said road, a distance of 310 feet, more or less, to a point that is 110 feet southeasterly of and at right angles to the centerline of said road at Station 39+63.59; thence southwesterly along a curve to the right (concave northwesterly) having a radius of 11,569.16 feet, parallel to the centerline of said road, a distance of 212 feet, more or less, to the point of beginning.
