KNOW ALL MEN BY THESE PRESENTS,

THAT IN CONSIDERATION OF Two Hundred Twelve Thousand Three Hundred Sixty Two Dollars and 00/100 (\$212,362.00) to the undersigned Grantors in hand paid by the Grantees herein, the receipt of which is hereby acknowledged, **BWA Development Corporation, an Alabama corporation**, (herein referred to as Grantors, whether one or more) do grant, bargain, sell and convey unto **John L. Waller and wife, Virginia L. Waller** (herein referred to as Grantees, whether one or more) as joint tenants, with right of survivorship, the following described real estate, situated in the State of Alabama, County of Shelby, to-wit:

Lot 14, Country Club Village, an Inverness Garden Home Community, as recorded in Map Book 16, Page 47, in the Probate Office of Shelby County, Alabama.
