That in consideration of ONE HUNDRED THIRTY FOUR THOUSAND & NO/100----  
(\$134,000.00) DOLLARS to the undersigned grantor or grantors in hand paid by the  
GRANTEES herein, the receipt whereof is acknowledged, we, Alfred W. Coon, Sr. and  
wife, Ina M. Coon (herein referred to as grantors), do grant, bargain, sell and  
convey unto John C. Brasher and wife, Bette W. Brasher (herein referred to as  
GRANTEES) for and during their joint lives and upon the death of either of them,  
then to the survivor of them in fee simple, together with every contingent  
remainder and and right of reversion, the following described real estate,  
situated in Shelby County, Alabama, to-wit:



Lot 1, Block 3, according to the Survey of Indian Wood Forest, Third Sector,
