The corporation is a close corporation authorized by 10-2A-300 through 10-2A-313, Code of Alabama (1975), as amended.

ARTICLE X

Prior to any transfer of restricted securities of the corporation the holder thereof shall be obligated to offer to the other holders of the securities of the corporation an opportunity, to be exercised within a reasonable time, to acquire the said securities. This shall be a right of first refusal and must be offered in writing by the seller to all entities registered as holders by corporate records on the date the said offer is made. All of the corporation's issued shares of all classes, exclusive of treasury shares, shall be held of record by not more than fifteen (15) persons.

Any amendment to terminate the corporation's status as a close corporation must be approved by a vote of the holders of record of at least one third (1/3) of the shares of each class of stock of the corporation which are outstanding.
