WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS, that in consideration of Ten dollars (\$10.00) dollars, to the undersigned Grantor, in hand paid the receipt of which is hereby acknowledged, We, **Raymond M. Garnem and Samia Michael Akl, a married woman**, (herein referred to as grantors), do grant, bargain, sell and convey unto, **Samia Michael Akl**, (herein referred to as Grantee) the following described real estate situated in Shelby County, Alabama, to-wit:

A part of the northeast $\frac{1}{4}$ -northeast $\frac{1}{4}$, the southeast $\frac{1}{4}$ -northeast $\frac{1}{4}$ and the northeast $\frac{1}{4}$ -southeast $\frac{1}{4}$ of Section 34, Township 19 South, Range 2 East, Shelby County, Alabama, more particularly described as follows:

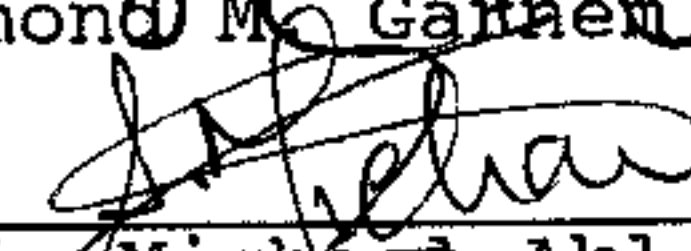
Beginning at the northeast corner of Section 34, Township 19 S, Range 2 E, Shelby County, Alabama, and run thence S $0^{\circ} 13' 40''$ E along the east line of said Section 34 2,612.34' to a point; thence run S $40^{\circ} 53' 23''$ W 1578.55' to a point on the northerly right-of-way line of Highway #280; thence run N $53^{\circ} 53' 46''$ W along said right-of-way line 44.22' to a point; thence run $35^{\circ} 18' 18''$ E 160.92' to a point; thence run N $25^{\circ} 36' 46''$ E 141.97' to a point; thence run N $9^{\circ} 34' 32''$ W 917.94' to a point; thence run N $0^{\circ} 00' 22''$ W 2642.05' to a point on the north line of said Section 34; thence run S $88^{\circ} 34' 07''$ E 1078.11' to the point of beginning, containing 77.66 acres less and except any rights-of-way or easements of record.

TO HAVE AND TO HOLD unto the said Grantee, his, her or their heirs and assigns forever.

And we do for ourselves and for our heirs, executors and administrators covenant with the said Grantee, his, her heirs and assigns, that we are lawfully seized in fee simple of said premises; that they are free from all encumbrances

of said premises; that they are free from all encumbrances unless otherwise noted above; that we have a good right to sell and convey the same as aforesaid; that we will and our heirs, executors and administrators shall warrant and defend the same to said Grantee, his, her, heirs and assigns forever, against the lawful claims of all persons.
