1. That the undersigned Lonnie Tennison, Gay Peacock, Michael Spney, Curtis Jackson, Melonee Spney, Brenda Bottoms were duly elected Trustees of Grace Missionary Baptist Church, Saginaw, on the 21<sup>st</sup> day of February, 1993. All of the above said Trustees also comprise the Deacons of the Grace Missionary Baptist Church, Saginaw. If any of the said Trustees shall decease or no longer be members of the Church, his position as Trustee will automatically be vacated and the person filling the position as Deacon for such member will become, by virtue of his position, a member of the Board of Trustees.

2. That the Corporate name of said Church shall be: Grace Missionary Baptist Church, Saginaw, Alabama.

3. That the County in which the Corporation will exercise its functions is Shelby County, Alabama.

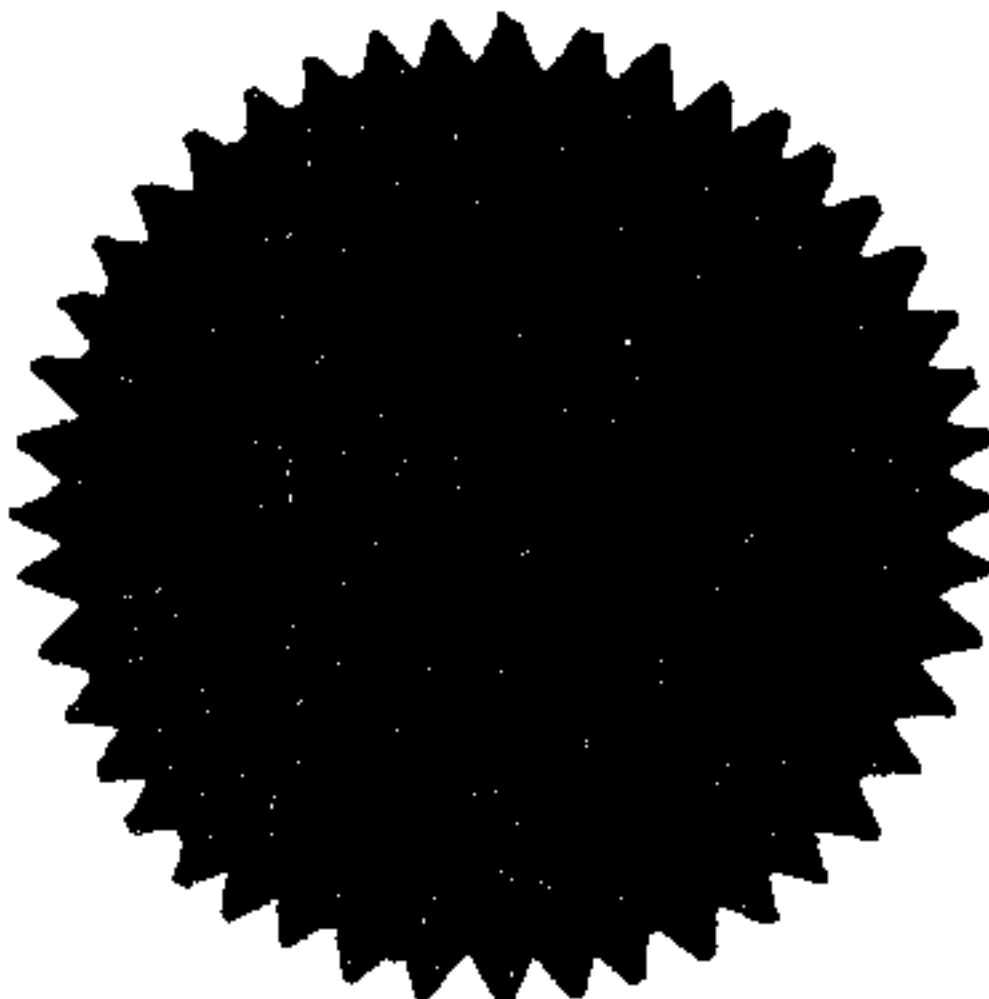
