Smyer, a unmarried (wo)man, who is one and the same as Ingrid Frances Smyer-Dubrow (hereinafter collectively called "Smyer") and Big Pine Fishing Club, an Alabama corporation (hereinafter called the "Club").

WITNESSETH

WHEREAS, by deed dated May 29, 1963, and recorded in Book 225, Page 560 in the office of the Judge of Probate of Shelby County, Alabama, S. W. Smyer, Jr. conveyed to the Club land in parts of Sections 24 and 25, Township 18 South, Range 1 West, Shelby County, Alabama on which are situated two fishing lakes ("Club Land"); and

WHEREAS, Smyer desires to secure an easement across the dam of the northernmost lake on the Club Land; and

WHEREAS, Club desires to secure an easement for a natural buffer around the lakes located on the Club Land.

NOW, THEREFORE, in consideration of the mutual agreements herein made, the parties hereby agree, grant and covenant as follows:

- 1. If and when a golf course is constructed on Smyer land adjacent to the Club Land (the "Smyer Land"), the Club agrees to grant to Smyer an easement for a golf cart path across the dam of the "little" lake on the Club Land (the most northerly lake), provided that the construction and use of such cart path will not adversely affect the structural integrity of said dam.
- 2. Smyer does hereby grant, bargain, sell and convey to the Club an easement over the Smyer Land to the extent necessary to establish a natural buffer extending 100 feet from the water's edge of the two lakes now situated on the Club Land, it being understood and agreed by the parties hereto that such easement shall only be established with respect to those areas of the Smyer Land located within 100 feet of the existing water's edge of the two lakes now situated on the Club Land, said easement (the "Easement") being granted subject to the following terms, covenants, conditions and limitations:
 - (a) The Easement herein granted is for the purpose of providing a natural buffer on which all construction and development shall be prohibited except as herein provided for.
 - (b) If and when a golf course is constructed on the Smyer Land some mutually agreed golf course use of the Easement would be permitted, provided such use does not compromise the benefits afforded Club by this Easement.
 - (c) If and when any golf course or residential, or other construction on Smyer Land is begun, Smyer will make every effort to protect the watershed of the lakes on the Club Land and not pollute the waters of such lakes.

3. The Easement and all rights and obligations hereunder shall run with the land and inure to and be binding upon the parties hereto and their respective heirs, executors, successors and assigns.
