

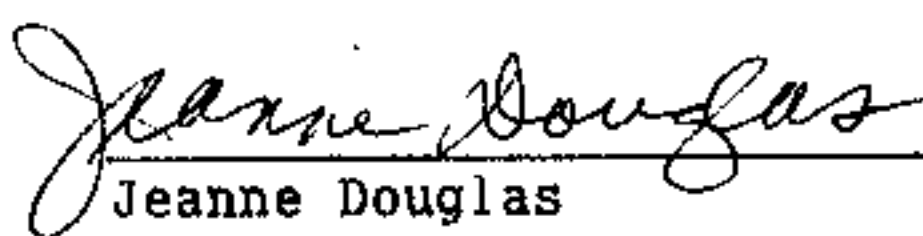
SATISFACTION OF MORTGAGE

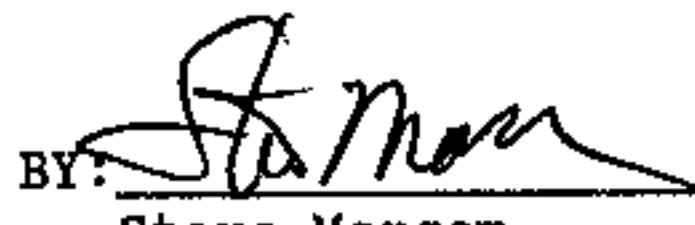

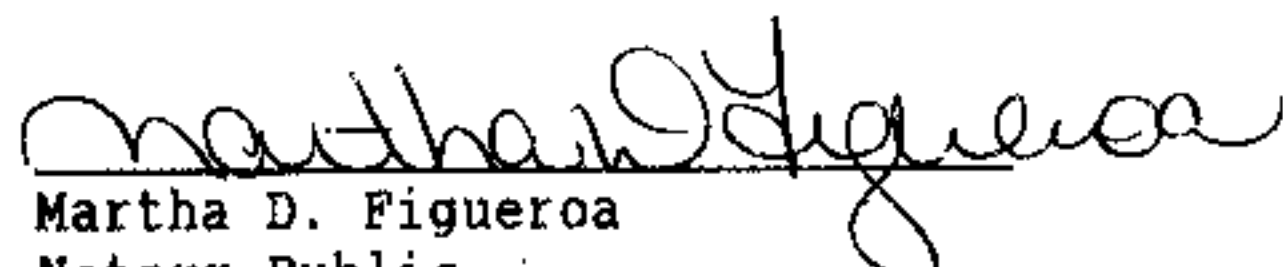
