KNOW ALL MEN BY THESE PRESENTS: That in consideration One Hundred Fourty One Thousand Five Hundred and 00/100 DOLLARS* (\$ 141,500.00****) to the undersigned Grantor or Grantors in hand paid by the Grantees, whether one or more, herein, the receipt of which is hereby acknowledged, we, Gary R. Hibler and Margaret M. Hibler, husband & wife, (herein referred to as Grantors) do grant, b a r g a i n , s e l l a n d c o n v e y u n t o Lisa B. Singer and Timothy D. Davis (herein referred to as Grantees) as individual owner or as joint tenants, with right of survivorship, if more than one, the following described real estate, situated in the State of Alabama, County of Shelby, to-wit:

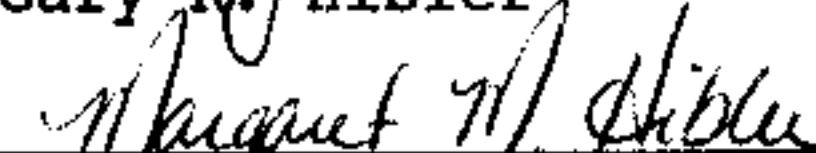

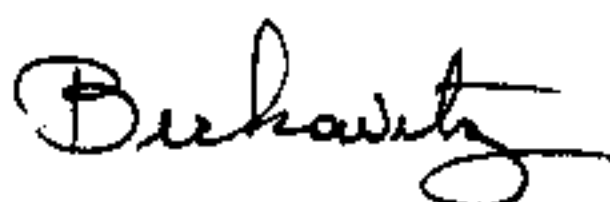
