HARRIS and husband, ROBERT L. HARRIS, (herein referred to as Grantors) do grant, bargain, sell and convey unto JAMES A. KELLY, JR., AND JANICE T. KELLY (herein referred to as Grantees) as joint tenants, with right of survivorship, the following described real estate, situated in the State of Alabama, County of SHELBY, to-wit:

Subject to existing easements, restrictions, set back lines, rights of ways, limitations, if any, of record.

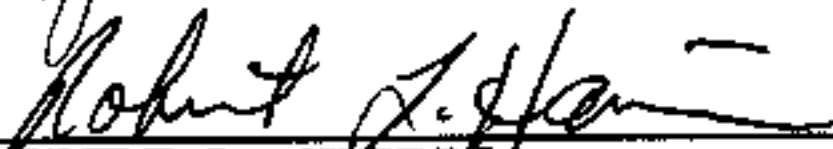
\$145,000.00 of the purchase price recited above was paid from a mortgage loan closed simultaneously herewith.

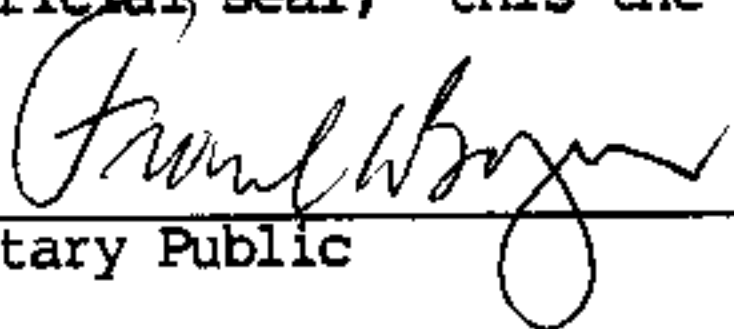
