The undersigned acting as incorporators of a corporation under the Alabama Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is Contract Drillers, Inc.

SECOND: The period of its duration is perpetual.

THIRD: The purpose for which the corporation is organized is to do geotechnical and environmental drilling into the earth for obtaining specimens, examining soil structure and conditions at various depths beneath the surface and any or all lawful business for which corporations may be incorporated.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue shall be One Thousand (1,000) Shares of common stock having a par value of \$1.00. The record owner of each share shall have one vote in all matters concerning the corporation at all annual and special meetings of the shareholders.

FIFTH: The corporation is a close corporation authorized by Section 10-2A-300 through 10-2A-313, Code of Alabama (1975) as amended.

Transfers of stock made on the books of the corporation and issuance of a new certificate shall be made only upon approval of the Board of Directors or the granting of a waiver of the required approval. The intent of this Article is to limit the holders of shares of this corporation to those of mutual interest. Should a shareholder desire to sell or otherwise dispose of any of his shares of the corporation he shall make such desire known in writing to the Board of Directors and the Board of Directors shall within one hundred and eighty days find a suitable buyer of the shares at a fair value. 
TENTH: All of the corporation's issued shares of all classes, exclusive of treasury shares, shall be held of record by not more than thirty (30) persons.


