AGREEMENT

NOW, THEREFORE, in consideration of the foregoing recitals, and as an inducement to the Lender to make the Loan to Borrower, Borrower does hereby sell, assign, transfer and set over unto Lender, its successors and assigns, all of the Borrower's interest in and to that certain Lease between Borrower, as Lessee, and the Industrial Development Board of the Town of Pelham, as Lessor, evidenced by Lease Agreement recorded in Deed 335 page 631, as modified by Amendment recorded in Deed Book 352, page 112 in the Probate Office of Shelby County, Alabama (the "Lease"), for the use or occupancy of the Property, and the improvements located or to be located thereon, including but not limited to the Borrower's right to purchase the Property granted in the Lease.

Borrower agrees to duly operate and maintain the Property and perform all requisites on its part to keep the Lease of said Property in full force and effect.

Borrower agrees that it has not and will not enter into any fictitious lease or any lease for the purpose of avoiding creditors, and any attempt to do so will be void. Borrower represents and warrants that all subleases, if any, presently in effect are, and all subleases hereafter entered into will be, arms-length subleases for a rental rate, which, in Borrower's best judgment, represents a fair market rental.

Borrower further agrees that this assignment is to remain in full force and effect so long as the Note remains unpaid and that it may be enforced by Lender.

It is expressly understood and agreed by Borrower and Lender that said Borrower reserves, and is entitled to retain, use and enjoy the Property unless and until the occurrence of an Event of Default pursuant to (and as defined in) the Loan Agreement, the Note, or the Mortgage, or until the violation of any term, condition or agreement of this assignment, each of which shall constitute an "Event of Default" hereunder.

Borrower does hereby authorize and empower Lender, upon demand, after any Event of Default hereunder, at the sole election of Lender, to assume possession and operation of the Property and to notify the Industrial Development Board of the Town of Pelham of Lender's assumption of the obligations of Borrower under the Lease and of the rights of Borrower under the Lease.

Borrower hereby agrees to indemnify Lender for, and to save it harmless from, any and all liability, loss or damage which Lender might incur under the Lease by virtue of this assignment, and from any and all claims and demands whatsoever which may be assessed against Lender thereunder or hereunder, and, without limiting the generality of the foregoing, covenants that this assignment, prior to any such default by said Borrower and entry upon the Property by said Lender by reason thereof, shall not operate to place responsibility for the control, care, management or repair of said Property upon Lender, nor the carrying out of any of the terms and conditions of the Lease; nor shall it operate to make Lender responsible or liable for any waste committed on the Property by the Lender or any other party, or for any negligence in the

management, upkeep, repair or control of the Property resulting in loss or injury or death to any licensee, invitee, employee, stranger or other person.

The terms "Note", "Mortgage" and "Loan Agreement" shall refer to such instruments as they may hereafter be amended by Borrower and Lender. This agreement shall be binding upon the Borrower, his heirs and assigns and subsequent tenants of the Property, or any part thereof, and shall inure to the benefit of Lender, its successors and assigns and any holder of the Note.
