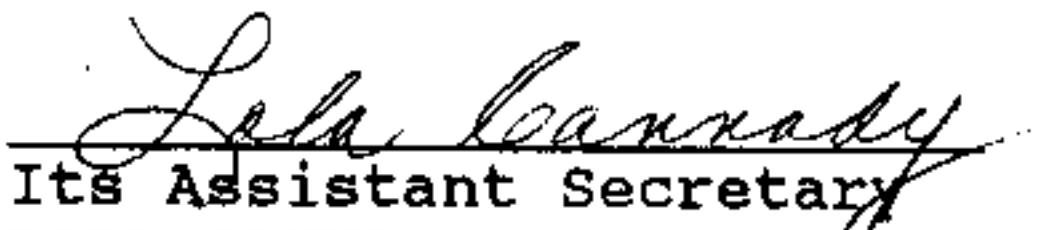

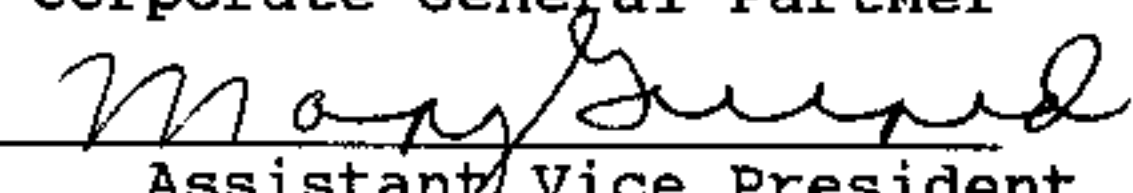
MORTGAGE SATISFACTION

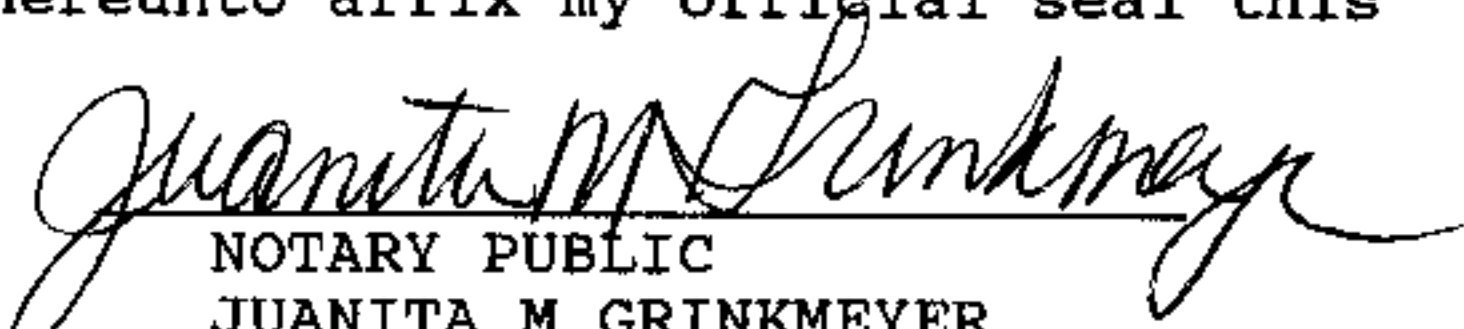
